Payment Rates and Terms

1. The practice is not contracted to any medical aids. I understand that I will be billed for a consultation at the rates indicated and should my medical scheme not cover the costs of this consultation, I undertake to cover any shortfall or amount that my medical scheme does not cover.
2. Prices have been based on national medical aid rates with some slight differences.
3. The rates are increased annually while continually following the national medical aid fees and should any alterations to fees be brought into effect, written notice will be provided via email.
4. The person signing the rates and terms will be responsible and liable for the account fees.
5. Invoices will be emailed on or around the 23rd of each month and payment must reflect by the 1st of the following month. The bank details are reflected on the invoice.
6. In the case of unpaid accounts, therapy sessions will be suspended until outstanding accounts have been settled in full and proof of payment has been emailed to info@roomtospeak.co.za.
7. The practice reserves the right to charge interest on overdue accounts. Interest charged will be at a rate determined in accordance with Section 1 (2) of the Prescribed Rate of Interest Act, 1975. If accounts are paid within the same month as issued, interest will ordinarily not be applied. If you neglect to settle your account, a third party will be contracted to recover outstanding monies. Any administrative or legal costs involved in the collection of monies owed will be for your account. Any and all legal costs will be recoverable on an attorney and own client scale.
